Initiating the debate on the Bill in the Lok Sabha, Deputy Leader of the Congress Gaurav Gogoi expressed concern over the intentions of the government for bringing the Bill.

"Today, they have their eyes on the land of a particular community; tomorrow, they will target the land of other minorities in society," he said.

The accused attended the training hardly a week before the incident occurred on 31 March night that claimed eight lives, including four babies, all belonging to his family.

Bengal Fire Services Act. All the deceased and injured people belong to the Baniks, who have run the manufacturing business of firecrackers for the past 10 years.

Two of the deceased babies are below one year while two others are toddlers. Three others sustaining severe burn injuries are undergoing treatment at Diamond Harbour Medical College Hospital.

The Baniks have 11 members, including an 80-yearold Prabhaboti Banik, Chandranath's grandmother.

### Bengal illegal firecracker factory blast: Role of panchayat under scanner

After eight people died in a blast at an illegal firecracker factory at Patharpratima in West Bengal's South 24-Parganas district, the role of the local panchayat has come under the scanner of investigating officials.

The blast took place on Monday night. District administration sources said that it had been revealed that the Banik family, at whose residence the illegal firecracker was being run, had secured an ordinary trade license from the local panchayat, which did not come with the permission to run a firecracker manufacturing unit.

Now, questions are being raised about how even that ordinary trade license was granted by the local panchayat, especially in the backdrop of criminal antecedents of one of the two arrested accused in connection with the blast, Chandrakanta Banik.

As per police records, Banik was arrested in 2022 for his involvement in the trading of illegal firecrackers and at that time, around 67 kilograms of illegal firecrackers were recovered from his possession.

Now, questions are being raised as to whether the local rural civic body granted that trade licence without background verification of the license application from the local police.

At the same time, questions are also being raised on how the local police did not have the knowledge that an illegal firecracker factory was being run at the residence by virtue of that ordinary trade licence that did not carry permission to run a firecracker manufacturing unit.

Local people have already claimed that the cops had ignored repeated alerts of a possible mishap because of the illegal firecracker factory being run from the Banik residence.

Tushar Banik, the brother

of Chandrakanta Banik, the joint owner of the residence where the illegal firecracker factory was being run, is still absconding.

Police have registered a case against the Banik brothers under Section 287 (negligent conduct concerning fire or combustible matter endangering human life or causing harm), Section 288 (negligent conduct concerning explosive substances potentially endangering human life or causing injury), Section 105 (culpable homicide not amounting to murder), Section 110 (attempt to commit culpable homicide), Section 125 9 endangering human lives) and Section 61 (criminal conspiracy) of the Bharatiya Nyaya Sanhita (BNS).

Additionally, they have been booked under Sections 24 and 25 of the West Bengal Fire Services Act, 1950. The last two sections are related to running of firecracker manufacturing business without a proper licence for the same.

**TMC worker shot**

Tension flared up in Belgharia after a Trinamul Congress (TMC) worker was shot dead at point-blank range late on Tuesday night. Police said that the deceased, identified

as Rehan Khan (aged between 30 and 35). The victim was reportedly a close aide of local TMC councillor Debjani Mukherjee. The incident took place in front of the party office in ward 35, triggering unrest in the area.

According to local sources, miscreants targeted Rehan late at night, leaving him grievously injured. Shockingly, his body remained at the spot throughout the night. On Wednesday morning, he was rushed to Sagar Dutta Hospital, where doctors declared him dead. The murder has sent shockwaves through political circles. The Barrackpore Police Commissionerate has launched a manhunt for the attackers. Police are probing whether the killing was linked to business disputes, personal enmity, or

Rehan was attacked late at night and left grievously injured, with his body remaining at the spot until morning.

political rivalry. Eyewitnesses described a disturbing scene. "In the morning, we saw his body being taken away in a toto to the hospital. There was a visible hole at the back of his head. It seemed like a gunshot wound," said a local resident. A police officer involved in the investigation stated: "He was sitting at the place talking. We even found a liquor bottle at the spot, suggesting he might have been drinking. His family informed us that they spoke to him

between 11.30 p.m. and midnight. His body was recovered around 5.30 a.m. We are trying to identify who was present at the time and who might be responsible.'

The Odisha government has failed to take effective measures to recover Rs 3,966.34 crore in fines imposed by the Supreme Court for illegal mining, according to a performance audit report by the Comptroller and Auditor General (CAG).

The Supreme Court, in its August 2017 ruling, directed the state government to impose penalties on mining companies that had extracted iron ore and manganese without proper environmental or forest clearance. The court mandated that 100% of the illegally mined minerals' value be recovered from the mining lessees.

The report stated that all outstanding dues were to be deposited with the Odisha Mineral Bearing Areas Development Corporation (OMBADC) by December 31, 2017. A central empowered committee had recommended the collection of Rs 19,174 crore in fines from 131 mining leaseholders who had violated regulations.

However, as of December 2017, only 82 mining lessees had paid Rs 8,289.87 crore,

### Infant dies at child care home even as husband waits for custody

The death of a 26-day-old infant in a child care institution here sparked a controversy here even as the family was waiting for the child to be handed over to them.

The situation arose when a25-year-old married woman, Sumitra Behera, identified herself as unwed at the hospital and handed over her newborn to the Child Welfare Committee (CWC), allegedly as an act of defiance against her in-laws. Sumitra Behera, posed as an unwed mother and concealed her husband;s name while admitting herself to the



District Headquarters Hospital (DHH) for delivery. Upon suspicion, DHH Superintendent Saroj Jena sought police and CWC intervention. Investigations later revealed that Sumitra was indeed married but had taken this step to sever ties with her husband, citing years

of domestic abuse. After delivery, she refused to hand over the child to her husband and in-laws and instead entrusted the newborn to the CWC for care and protection. Her husband, Chabbi Behera claimed that he had repeatedly approached CWC officials to gain custody of his son but was denied access. Today, when we came to

take him home, we were informed that he had died. This is shocking and heartbreaking, said Chabbi Behera. He alleged negligence on the part of the CWC, stating that the lack of timely medical care. District Child Protection

Officer Kanhu Charan Rout confirmed that Sumitra had initially declared herself unwed. "Five days later, our inquiry revealed that she was married. A man then claimed to be the father of the child, and verification was ongoing when the child passed away," he stated. Jagatsinghpur police have

registered an unnatural death case and sent the body for post-mortem.

Probe Committee finds no evidence against previous BJP regime



The resolution moved by Chief Minister MK Stalin received the support of all parties, including the BJP. Floor leaders of all parties spoke on retrieving the islet to protect the fishermen from being harassed and arrested by the island nation's Navy, which also impounded their boats.

The 285-acre barren uninhabited islet, which has a shrine to St Antony in the

lution, the retrieval of the islet alone could provide a lasting solution to safeguard the traditional fishing rights of the fishermen of Tamil Nadu's southern coast. 

The JAC demanded a freeze on the delimitation exercise for another 25 years. It has also appealed to the Prime Minister to declare

this on the floor of Parliament. Prior to this, Stalin had convened an all-party meeting in Tamil Nadu, which was attended by nearly 50 registered political parties, barring the BJP.

"The voices emerging from our deliberations transcend political boundaries, embodying the concerns of citizens from diverse regions who seek fair representation in our parliamentary democracy. As this issue holds significant importance to our states and citizens, I kindly request a meeting with you to formally submit the Memorandum on behalf of the Joint Action Committee," the letter read, expecting a positive response at the earliest.

Jaipur blast conspiracy accused arrested: The Madhya Pradesh police have arrested Firoz Khan, the prime accused who had been absconding for three years in the 2022 case related to the conspiracy to carry out blasts in Jaipur, from Ratlam city in MP in the intervening night of Tuesday and Wednesday, said police officials. 


#### **Powerful signal**

rime Minister Narendra Modi's visit to the Rashtriya Swayamsevak Sangh (RSS) headquarters in Nagpur is more than just a routine event ~ it is a powerful political signal. As the ideological fountainhead of the ruling Bharatiya Janata Party, the RSS wields considerable influence over the party's direction, policies, and electoral strategies. #### **French turmoil**

he decision to bar Marine Le Pen from running for public office for five years is nothing short of seismic for French politics. With her far-right National Rally (RN) gaining ground over recent years, Ms Le Pen's absence from the 2027 presidential race reshapes the political landscape in ways that are both predictable and unpredictable. While legal consequences must apply to all politicians equally, the broader implications of this ruling raise pressing questions about democracy, political strategy, and the future of France's right-wing populism. Ms Le Pen's conviction for misappropriating European funds and her subsequent sentencing, including a prison term and financial penalties, reinforce the principle that no politician is above the law. At the heart of the case was a system of using European Parliament funds to pay staff who worked primarily for RN, an act deemed as fraud by the courts.

The ruling sends a strong message about accountability, particularly in an era when public trust in institutions is fragile. However, the immediacy of her disqualification ~ despite the possibility of appeal ~ introduces concerns about judicial influence over political processes, especially since past cases involving French politicians allowed more time before a ban took effect. The most immediate consequence of this ruling is the leadership vacuum within RN. Ms Le Pen was widely seen as the far-right's strongest candidate for 2027, with polls suggesting she could have mounted a formidable challenge to centrist governance. Now, her party must either rally behind a successor, most likely Jordan Bardella, or risk losing momentum. Mr Bardella, as RN's president, has positioned himself as a charismatic and competent figure, but whether he can command the same level of personal loyalty and electoral success remains uncertain. The ruling may force RN to accelerate its transition into a broader populist movement rather than relying on the Le Pen family brand. But this decision doesn't only affect the far right. French democracy itself now faces an intense debate on whether judicial rulings should have the power to reshape elections. Figures from both the left and the right, including Mr Jean-Luc Mélenchon and Mr Laurent Wauquiez, have expressed unease about a judge's decision effectively removing a popular politician from electoral contention. Their concerns tap into a larger question: should the electorate alone have the power to remove leaders, or is judicial oversight necessary to safeguard democracy from corruption? Ms Le Pen and her supporters will undoubtedly frame this as a political persecution, fuelling anti-establishment sentiment. When populist rhetoric thrives on narratives of victimhood and elite suppression, this ruling could backfire. Rather than diminishing RN's influence, it might galvanise its base, reinforcing the belief that the system is rigged against them. If the party can effectively channel this grievance into electoral gains in the legislative elections, the French political establishment may find itself facing an even stronger far-right movement.

himself for a fixed number of years (till he is sixty years old), with the assumption

He shut himself up in his cottage and lit a charcoal fire to fill the room with carbon monoxide. But somehow with ample leakages, his suicide attempt seemed halfhearted and it failed. He survived but with grave brain damage and lived out the remainder years of his life in a deplorable state. Maugham therefore wanted to show that it wasn't easy to end one's life. Virtual existences, instead of binding and bringing people closer in warm bonds of camaraderie, in physical proximity to each other and in forging genuine relationships, fan the frosty breeze of separation and solitariness.

to The Myth of Sisyphus, he writes, "The fundamental subject of The Myth of Sisyphus is this: it is legitimate and necessary to wonder whether life has a meaning; therefore it is legitimate to meet the problem of suicide face to face. The answer, underlying and appearing through the paradoxes which cover it, is this: even if one does not believe in God, suicide is not legitimate. Written fifteen years ago, in 1940, amid the French and European disaster, this book declares that even within the limits of nihilism it is possible to find the means to proceed beyond nihilism. In all the books

I have written since, I have attempted to pursue this direction. Although The Myth of Sisyphus poses mortal problems, it sums itself up for me as a lucid invitation to live and to create, in the very midst of the desert."

And hence, concluding in words of Camus again:

"I leave Sisyphus at the foot of the mountain! One always finds one's burden again. But Sisyphus teaches the higher fidelity that negates the gods and raises rocks. He too concludes that all is well. This universe henceforth without a master seems to him neither sterile nor futile.

"Each atom of that stone, each mineral flake of that nightfilled mountain, in itself forms a world. The struggle itself toward the heights is enough to fill a man's heart.

"One must imagine Sisyphus happy."

So life may be a desert, but it is up to us to create forests in it, we may be given a huge stone to roll up a mountain knowing very well that it will roll back, but it is we who will have to accomplish the feat, it's we who will have to arrange to have meals together, and look out for each other, it's we who will have to return lost wallets and show kindness to others, it's we who will have to feel the breeze and the sun on our skin and start living, start wanting to live like the toad and all living beings, it's we who will have to stop being lotus eaters and start seeking like meaningfully, not just spending it like a burden. It is up to us to be happy Sisyphuses.

# Of women's rights and global chauvinism

Women's rights and their role as bridge-builders today, connecting between the multilateral and local settings? A recent seminar at the Thai Ministry of Foreign Affairs (MFA), hosted by its International Studies Center, elaborated upon the situation in a world witnessing tumultuous changes.

Notably, there has never been a woman UN Secretary General, nor, for Thailand, a woman Minister of Foreign Affairs. Less than 20 per cent of key politicians at the national and local levels in this country are women. Yet, there has been some progress due to welcome changes of laws, policies and practices, such as the country's Gender Equality Act. Of course, the country's Prime Minister is a woman, but the fate of her aunt, also a PM, overturned by a coup d'etat, should not be overlooked.

The fickleness of international and national politics interplays with the fate of women's rights, especially their implementation. Currently, the post-World War II multilateral framework is being compromised, if not dismantled, by rampant nationalismcum-transactionalism, with an introspective vibe at the apex of the superpower level. There is an ideological undercurrent which seeks to stifle a more liberal interpretation of women's rights and to upstage the gains which have been enjoyed by all, including the impetus from the UN's Sustainable Development Goals (SDGs). Beware of the rambunctious chauvinism emanating from key international players, whether in peace or in war!

times. The most prominent instrument safeguarding women's rights is the Convention on the Elimination of Discrimination against Women (CEDAW).

The CEDAW Committee which supervises the treaty's implementation has been broadminded to interpret women's rights to cover sexual orientation and gender identity, shaping welcome space also for lesbians and transgender communities. A couple of years ago, it ruled in a seminal case concerning a South Asian country that an old colonial law prohibiting same sex relations between women was in breach of the CEDAW's anti-discrimination provisions. This is complemented well by Thailand's most recent reform with a marriage equality law enabling same sex marriages.

That openness to change needs to be well protected. If there are cracks in the nodes of multilateralism today, the advocacy to sustain and strengthen advances on the part of humanity needs to be astutely supported. The CEDAW remains important. The SDGs, especially their targets to eradicate gender-based violence and discrimination, are value added for global and national programmes propelling gender-transformative change.

What has this Working Group recommended to Thailand? Among a myriad number of findings, some are particularly significant. A JARRING note in the chorus of congratulations which has hailed the achievement of Sir Sefton Brancker, and the selection of Karachi as the main air depot for India, is struck by Commander Burney, M.P., the originator of the Empire airship mail and passenger service scheme, and also the inventor of the plan for carrying passengers inside instead of outside the giant envelope of the airship. "Personally," he declared to an Australian newspaper representative the other day, "I disagree with the Air Ministry's plans for an airship service calling at Egypt, Karachi, Bombay, Calcutta, Rangoon, and Singapore." The Commander would prefer an arrangement with stops only at Baghdad, Colombo, Freemantle, and Wellington. This plan would enable Freemantle to be reached in six and a half days, and Wellington in nine days from London. He would not, however, leave India entirely in the cold-metaphorically speaking. Night flying aeroplanes would carry the mails to distant parts of India and Australia; but so far as Commander Burney is concerned, Karachi might whistle for such a thing as passengers by airship.

#### PACT OF THE FIVE POWERS FRANCE & ENTRY OF GERMANY

(" TIMES ? WECIAL SERVICE.) LONDON, APRIL 1.

THE Italian attitude towards the Security problem would seem to coincide with that of the British, declares the Rome correspondent of The Times. The Government strongly favours a five- power pact between Britain, France, Italy, Belgium, and Germany. This, it is believed, would be best accomplished by the four first-named states agreeing among themselves on the main lines governing the Pact, and thereafter inviting Germany to subscribe to the agreement. The French Government's view, states The Times Paris correspondent, is that the opening of security negotiations with the idea of the inclusion of Germany, should be conditional upon the receipt of satisfactory information regarding the following points : • Germany must define her new attitude towards the League of Nations. • If she is admitted at Geneva, is she prepared to assume all obligations connected therewith? Is she still bent on securing an Austrian reunion?

The global community and friends of women's rights need to be more strategic in these fluctuating To this should be added the need to realign global partnerships and alliances so that beyond the superpower realm, countries of the middle to higher power spectrum must cooperate more resolutely to overcome the assistance-cum-protection vacuum.

Those propositions will doubtlessly be re-visited when the country next appears before the CEDAW Committee, tentatively in 2025. Ostensibly, women's rights and roles as bridgebuilders of peace, human rights, democracy and sustainable development, connecting between multilateral/international standards and local wisdom, are at the heart of every society, without exception. And navigating the uncharted course of the future will invite not only dexterity and creativity but also empathy for all.

### Culture wars that reshape societies

nyone who grew up watching Disney's classic animated film Snow White might find Lits recent live-action remake jarring. The fair-skinned Snow White of the original has been replaced by Rachel Zegler, a Latina actress with a darker complexion. The princess is no longer a passive damsel awaiting rescue by a prince but an assertive heroine who fights the Evil Queen and forges her own destiny. These changes have sparked a heated debate in the US. Some praise the remake for promoting racial diversity and challenging gender stereotypes, while others argue it strays too far from the original, embracing political correctness to an extreme.

This controversy highlights the growing cultural polarization in the US, exacerbated by President Trump's opposition to progressive ideals. Preaching traditional family values, Trump has waged a culture war against so-called "wokeness," which promotes diversity, equity and inclusion. Since taking office, he has issued a series of executive orders aimed at reversing progressive policies of the past. For instance, he has threatened to defund universities that allow transgender women to compete in women's sports. Trump has also pushed to revoke birthright citizenship for children of undocumented immigrants, despite constitutional protections.

correctness in the US has gone too far. In Snow White, for example, some critics have labelled the prince's kiss on the sleeping princess as sexual harassment due to a lack of consent — an argument many find excessive. Similarly, transgender athletes competing in women's sports often retain biological advantages, raising concerns about fairness. Additionally, some women engage in "birth tourism," entering the US late in pregnancy to secure citizenship for their children, who sometimes later serve as "anchor babies" for family members seeking green cards.

Despite these issues, Trump's policies challenge the fundamental principles of the US, a nation built by immigrants. The first English settlers were, in fact, undocumented immigrants. Many believe the country's racial and cultural diversity has been a key to its strength and prosperity. They warn Trump's nativist and ethnocentric policies can stifle its dynamism. On a practical level, mass deportations of undocumented immigrants could also harm industries like agriculture and construction, which rely on their cheap labour.

The culture war is not unique to

diverse and multicultural. As birth rates plummet and the population shrinks, Korea faces an urgent need to accept more immigrants.

The number of foreigners in Korea is steadily rising. Last year, they made up a record 4.9 per cent of the total population, up from 3.8 per cent in 2021. That figure is expected to surpass 5 per cent this year, the threshold for multicultural status set by the Organization for Economic Cooperation and Development. Analysts predict it will reach 7 per cent by the early 2040s. Immigration could help offset Korea's declining population, which has fallen by 500,000, or about 1 per cent, over the past five years.

Yeongam County in North Gyeongsang Province exemplifies the crisis. Each year, only about 25 babies are born in that county, while around 300 people die. Over the past two decades, the county's population has plummeted by 25 per cent to just 15,000 - the lowest among all Korean counties. In a desperate effort to reverse this trend, local officials recently announced plans to invite about 40 Myanmar refugees currently living in Thai border camps under UN protection. Authorities believe the refugees' Confucian and Buddhist traditions will help them integrate into Korean society. As Korea grows more multicultural, social tensions are emerging. In the southern city of Daegu, a plan to build an Islamic mosque has faced fierce local opposition, with residents staging a pork barbecue protest and



prominently displaying a pig's head — an overt insult to the Islamic religion. Foreign brides often struggle with language and cultural barriers, and marriages have high rates of domestic violence and divorce. Meanwhile, foreign workers frequently report discrimination at workplaces and poor working conditions.

But Korea's cultural divisions extend beyond race and immigration. Sharp divides based on gender, generation, region and religion have fueled internal conflict. Young women, particularly in their 20s and 30s, overwhelmingly support progressive ideals and the opposition Democratic Party, while young men lean conservative and favour the ruling People Power Party. The longstanding regional rivalry between the liberal southwestern Jeolla provinces and the conservative southeastern Gyeongsang provinces remains strong, often leading to mutual animosity. Religious divides also

contribute to tensions, with Christians generally holding more conservative views than non-Christians.

In many ways, Korea is beginning to resemble the US, where political and ideological confrontations deepen cultural rifts. Elections are increasingly decided along gender, generational and ideological lines. Recent protests over President Yoon Suk Yeol's impeachment illustrate this stark divide. Opponents of impeachment include Christians, young men and south-eastern residents, while supporters include a lot of young women and people from the southwest.

Already divided from North Already divided from North Korea, South Korea cannot afford further internal fractures. As the country navigates its evolving identity, finding common ground will be essential to maintaining national unity.

American Secretary of State Marco Rubio travels this week to a gathering of top diplomats from NATO countries and is sure to find allies that are alarmed, angered and confused by the Trump administration's desire to reestablish ties with Russia and its escalating rhetorical attacks on longtime transatlantic partners.

Allies are deeply concerned by President Donald Trump's readiness to draw closer to Russian leader Vladimir Putin, who sees NATO as a threat, amid n American effort to broker a ceasefire in Ukraine. Recent

White House comments and

insults directed at NATO allies Canada and Denmark — as well as the military alliance itself — have only increased the angst, especially as new American tariffs are taking effect against friends

and foes alike. Rubio arrives in Brussels on Thursday for two days of meetings with his NATO counterparts and European

officials, and he can expect to be confronted with guestions about the future U.S. role in the alliance.

For 75 years, NATO has been anchored on American leadership, and based on what they have seen and heard since Trump took office in January, European officials have expressed deep concerns that Trump may

meet for a June summit in the Netherlands.

As Rubio did last month at a meeting of foreign ministers from the Group of 7 industrialised democracies, America's top diplomat, who is regarded by many overseas as a more pragmatic and less dogmatic member of Trump's administration, may be able to salvage a watered-down group consensus on the war in Ukraine.

That's even as Trump said this week that Ukraine "was never going to be a member of NATO" despite leaders declaring at last year's summit that the country was on an "irreversible" path to join.

### Cory Booker sets a record with marathon Senate speech

In a feat of determination, New Jersey Democratic Sen. Cory Booker held the Senate floor with a marathon speech that lasted all night and into Tuesday night, setting a historic mark to show Democrats' resistance to President Donald Trump's sweeping actions.

Booker took to the Senate floor on Monday evening, saying he would remain there as long as he was "physically able."

It wasn't until 25 hours and 5 minutes later that the 55-year-old senator, a former football tight end, finished speaking and limped off the floor. It set the record for the

longest continuous Senate floor speech in the chamber's history. Booker was assisted by fellow Democrats who gave him a break from speaking by asking him questions on the Senate floor.

It was a remarkable show of stamina as Democrats try to show their frustrated supporters that they are doing everything possible to contest Trump's agenda.

Yet Booker also provided a moment of historical solace for a party searching for its way forward: By standing on the Senate floor for more than a night and day and

India's Manufacturing Purchasing Managers' Index (PMI) rose to 58.1 in March 2025, up from 56.3 in February, and its highest mark in 8 months.

According to data released by HSBC and compiled by S&P Global, the rise was driven by stronger new orders growth, as the New Orders Index reached its highest level in eight months, supported by increased customer interest, favourable demand conditions,

### **Rupee projected to trade in range of 85.5-87.5 per dollar in FY26**

NEW DELHI, 2 APRIL

The performance of Indian rupee in FY25, when compared with other global currencies, was relatively stable, with a stronger dollar weighing on all major currency pairs, a report showed on Wednesday.

However, towards the end of the year, a reversal in dollar strength and FPI inflows into debt supported a rally in rupee, with the domestic currency recouping as much as 2.4 per cent in a singlemonth alone, according to a report by Bank of Baroda (BoB).

The coming year is likely to be marked by a period of volatility, awaiting clarity on US tariff policies. This will also set the stage for the US Fed's rate actions, in turn, affecting how the dollar behaves.

### Curious case of GST on popcorn: A 'namkeen,' packaged & sweet saga

Popcorn, the ubiquitous snack of movie nights and casual munching, has found itself embroiled in a surprisingly complex tax tale in India.

The Central Board of Indirect Taxes & Customs (CBIC) has recently stepped in to clarify the labyrinthine Goods and Services Tax (GST) rates applied to this seemingly simple treat, revealing a three-tiered structure that distinguishes between the salty, sweet, and packaged varieties.

To bring clarity to ongoing disputes, the CBIC has announced that rate disputes on specific categories of popcorn up to February 14th will

Council, issue for past period up to 14.02.2025, is hereby regularised on 'as is where is' basis," a recent circular declared. This move, prompted by requests, followed the GST Council's decision in December 2024 to issue a detailed clarification.

The crux of the matter lies in the distinction between loose, packaged, and sweetened popcorn. According to the CBIC, ready-to-eat popcorn mixed with salt and spices

Now let us understand the taxation journey of this popular snack-from simple to stratified. For decades, popcorn enjoyed a relatively straightforward tax treatment. Prior to the 55th GST Council meeting, a uniform 5 per cent GST rate applied to both loose and prepackaged popcorn, aligning attracts a 5% GST if sold loose, with the taxation of other non-



luxury food items. However, the 55th meeting ushered in a new era of granular classification, driven by packaging, ingredients, and preparation methods.

Before, whether you grabbed a bag of popcorn at the theatre or bought a prepackaged version from the store, the tax was the same. Now, the 55th GST Council

Meeting has made the following changes:

Loose Popcorn (Unpackaged): Remains at 5 per cent, consistent with its classification as a basic snack. Pre-Packaged Popcorn: Now taxed at 12 per cent, reflecting its status as a packaged food item.

**Caramelized Popcorn:** Sees a significant jump to 18 per cent, aligning it with other sugar-based confectioneries, similar to candies and chocolates.

As a clarification, popcorn served to customers in theatres in loose form will continue to attract a rate of 5 per cent as applicable to 'restaurant service'

as long as supplied independently of the cinema exhibition service. Once bundled with Movie Tickets, there is another layer of complexity and the GST rate for the entire bundle is determined by the movie ticket's GST rate. If the movie ticket is taxed at 12 per cent GST, the popcorn bundled with it will also be taxed at 12 per cent, even if it is loose popcorn. If the movie ticket has a GST rate of 18 per cent, the entire combo, including the popcorn, will be taxed at 18 per cent, satisfying the test of composite supply.

Evidently, the rationale behind these varying rates lies in the perceived characteristics and also venue of consumption

of each popcorn type. Ultimately, the popcorn saga reveals more than just tax rates; it's a mirror to the evolving landscape of consumer goods and the ongoing quest for clarity within India's fiscal framework. So, the next time vou reach for that buttery, salty, or sweet treat, remember: you're not just enjoying a snack, you're partaking in a surprisingly intricate economic drama, where every kernel carries a carefully calculated tax burden. While the CBIC's recent clarifications aim to resolve existing ambiguities, the curious case of popcorn taxation serves as a reminder of the dynamic nature of tax







regulations in India.

Indian women's hockey team forward Vandana Katariya, who retired from the international circuit on Tuesday, revealed drawing inspiration from legends like Dhanraj Pillay, Cristiano Ronaldo, and Usain Bolt to keep herself upbeat during her 15-yearlong career in the senior side.

Vandana finished as the most-capped player in the history of Indian women's hockey with 320 international appearances and 158 goals. She called it an emotional decision to hang up her boots. "It was a very hard decision to take. We stay with each other more than a family, so leaving them was an emotional decision. To feel and understand this decision is really difficult. Today I felt too emotional and took the decision to announce my retirement," she told a news agency.

Despite achieving multiple accolades over the years, the

Games to missing out on a medal and finishing fourth in the Tokyo Olympics. Among these, the Tokyo Olympics and the 2013 Junior World Cup are the most special moments for me," she asserted. "After Tokyo, it was difficult to forget that heartbreak, but we thought we would cover it up in Paris, as we learned a lot in that tournament. I missed the Paris Olympics Qualifiers in Rachi due to an injury. The team performed well, but I think luck was not on our side. Had we won the match against Germany, then we would have qualified for the Paris Olympics."

The veteran player added that she has learned to give herself more time in training to bring the best out of herself.

"I feel players must be disciplined in their diet, recovery, and fitness. We all train together with our coaches and support staff, but I feel players who give themselves extra time stand out. I've always played with high energy and

kept myself fit throughout my career," she said.

When asked about her longevity in the sport and her favourite athletes, Vandana credited international stars including Ronaldo and Bolt as playing a role in her career. "I'm a fan of Dhanraj Pillay as he was also a forward and also followed (Cristiano) Ronaldo and Usain Bolt a lot in my life. Players are very disciplined these days and are ready for the high-performance requirement of the Indian team," she revealed.

She further highlighted the impact of the Women's Hockey India League in uplifting the confidence of youngsters for future tournaments. "The Women's HIL was much-needed as it boosts the personal confidence of players. Even players other than the Indian camp also received an opportunity to prove themselves. We have a strong chance of clinching a medal in next year's World Cup and 2028 Olympics as the team is

doing really well."

"With the rise of hockey over the years, with the help of Khelo India, it is a good career opportunity for upcoming youngsters. The popularity of the game has reached the masses, and there is a good career for them in hockey now," she added.

The 32-year-old is yet to decide on her career ahead, but remains open to taking up a coaching role while confirming her participation in the next HIL as a player.

"I'm completely fit and I'm ready for any opportunity, including coaching (if required) and playing. I've not decided anything yet, nothing is coming to my mind. I will play in the next edition of the HIL. She played for the Shrachi Rarh Bengal Tigers in the inaugural edition earlier this year. Sharing her initial hardship,

IPL: After KKR, CSK, now LSG disappointed with home pitch

After Kolkata Knight Riders and Chennai Super Kings, Lucknow Super Giants became the latest Indian Premier League (IPL) franchise to have expressed their dissatisfaction with their home pitch after the Zaheer Khan-mentored side suffered an eight-wicket hammering at the hands of Punjab Kings in Tuesday's match played at the Ekana Stadium in Lucknow.

Visibly frustrated with the outcome, the former India left-arm quick said it seemed the Punjab Kings had brought their own curator to prepare the pitch as the tourists romped home with 22 balls to spare. "What was a little disappointing for me here," Zaheer said at the press conference. "Considering it's a home game and in IPL you've seen how teams have looked at taking a little bit of home advantage, from that point of view you've seen the curator is not really thinking that it's a home game. I think maybe it looked like, you know, it was Punjab curator out here. So that's something which we will figure. It's a new set-up also for me, but I hope that this is the first and the last game when it comes to that. Because you



are disappointing the Lucknow fans as well. They've come up with so much expectations of winning the first home game here. As a team, we are confident. We accept that we've lost the game, and we have got to do whatever it takes to make that impact in the home leg. We still have six more games to go here, and this team has shown in the season so far, whatever little cricket is played, that we have the right outlook and the mindset to look at the IPL. What you can expect is

innovation, out-of-the-box thinking, the fight, the hunger, and that sums us up as a team."

Arshdeep Singh, who starred with a three-wicket haul for Punjab Kings, acknowledged the help from the pitch, while expressing his disappointment at leaking in excess of 40 runs during LSG's innings. Besides Arshdeep, PBKS used the conditions well by employing their seam-bowling arsenal, comprising the likes of Lockie Ferguson, Marco Jansen and Marcus Stoinis to good effect.

In contrast, the home side, plagued by injuries to key players, mostly their pacers, had probably anticipated a slower surface, and thus went in with two seamers—Shardul Thakur and their lone overseas pacer Shamar Joseph.

On being asked if they might have misread the pitch in their first home game, Zaheer agreed, saying, "That's what we are saying. We will go according to what the curator tells us. We are not using this as an excuse. We have seen during the last season

that it's not like batters don't have to struggle here at times. All these things go on in cricket. But the way the home team should get support, everyone needs to know this is our home team that is playing in Lucknow and what can we do to help them win? Everyone's contribution is important. We will find a way anyway to win matches..."

At the post-match presentation, LSG skipper Rishabh Pant also spoke of his side expecting a 'slow wicket', while explaining his decision to go in with an extra spinner in M Siddharth instead of pacer Prince Yadav.

"The idea was to get a slower wicket. We felt it's a home game, it's going to stop a little bit. I think the slower ones, when bowled into the wicket, were still sticking in but we weren't good enough on the day. We have got to learn and move forward. It is our first home game. Still assessing the conditions," he said.

LSG have now lost two of their first three matches this season, with their home record slipping to just 7 wins in 15 completed games at the Ekana Stadium. They now await Mumbai Indians on 4 April, hoping to get their campaign back on track.

He has been instrumental for Australia in difficult situations, especially in the most recent Border-Gavaskar series at home, where he stepped up in the absence of Josh Hazlewood, who was ruled out due to injury after two games. Boland finished the series as the third-highest

wicket-taker in the series with 21 wickets despite only playing three Test matches.

This performance included a memorable 6/45 in the second innings of the final Test in Sydney as Australia secured a 3-1 series win, getting their hands on the Border-Gavaskar Trophy after more than a decade.

Boland has been nursing an injury to his knee sustained during the Sheffield Shield but is on the road to recovery for a busy period of cricket ahead.

"I think it's just working out what's working and what doesn't. I've only had this knee injury for eight to 10 months. I think we're going about it the right way. I'll have a little break now. But once I do get up and going, I'm hoping to just go really smoothly and if everything goes well, I'll be right to go

for that one Test in England and those three Tests in the Caribbean. And then after that, have another break again, and then sort of built my strengths and bowling loads again before the huge summer cricket next year, ' Boland added.

Boland will be competing with fellow pacers Josh Hazlewood, Pat Cummins and Mitchell Starc for a spot in the side for the final.

The aforementioned trio missed out on the Champions Trophy earlier this year due to injury and personal reasons following an action-packed summer of cricket, but have since made their return in the Indian Premier League. Australia will be looking to defend their title and retain their status as the best Test side in the world against first-time finalists, South Africa.
